Tikic, mi latryan guay tei guangtangh mak ge kai tei kasiamhlou sinic nthyam e khatnic kasiamh chuyrilou mak ge. Kaniw tei syan geicna tii ngam mak khourui electric khatnic dui laa ngam kan mak ge.
